City Council Uses "Salary" from Highest Paid Cities to Justify a 165% "Salary" Increase

West Covina City Council's compensation had not been increased since July 1, 1990. Some benefits and allowances were reduced or eliminated through the years due to budget concerns. At the September 19, 2023 the City Council unanimously voted to increase their compensation to the maximum allowed by law and to reinstate department head benefits and allowances. The new rates do not take effect until after November 2024 election. ^{1, 2}

This table is a modified version of the table included in the September 19, 2023 Staff Report showing surrounding cities councilmember compensation data. My estimate for the increased salary and benefits the West Covina City Council approved and/or is considering has been added in pink.

¹ California Government Code § 36516(a) limits councilmember salary increases to 5% for each calendar year from the operative date of the last salary adjustment in effect when the ordinance to increase the salary is enacted. West Covina's current rate was adopted in 1989. The effective date was 1990.

² The November 7, 2023 Staff Report erroneously refers to the September 19th City Council meeting as September 9. During the month of September, the Council Meetings were held September 5 and 19, respectively.

³ Annual Salary (aka stipend) is a fixed amount of money paid monthly for services and/or to defray expenses. \$2,027 is the maximum amount the City Council can increase their current compensation by law. The September 19, 2023 staff report estimates the impact to the General Fund at \$80,000 annually.

⁴ Other Pay includes auto allowance and expenditures for conferences, community events, phones, city-associated travel other expenditures outlined in the City Council Expense & Reimbursement Policy. The Auto Allowance is \$300 month.

- ⁵ Defined Benefit Plans are defined by the Internal Revenue Service as providing a fixed, pre-established benefit for employees at retirement. Information on West Covina's specific plan applicable to Councilmembers has been requested.
- ⁶ Retirement Cost are optional. When elected to office, councilmembers may select to retire through the city. Councilmembers elected after 2013 follow the Public Employees Pension Reform Act of 2013 which requires them to pay an appropriate share of pension costs as determined by law. The city pays the remaining cost.
- ⁷ Deferred Compensation Plan is \$300 per month which may be applied to a list of plans provided by the city, to medical dental, or life insurance premiums, or taken in cash in lieu of depositing funds in a deferred compensation plan.
- ⁸ Medical, Dental, Vision insurance is an option paid entirely by the councilmember. Deferred compensation may be used. REFERENCES
