This chart lists new political action committees (PAC) sponsorship and funding West Covina unions set-up in support of their sales tax increase effort--Measure WC as of December 10, 2019. It is a two-part process:

- Circulate a petition to collect the required number of signatures needed to get the union-sponsored sales tax.
- Get registered voters to vote for (support) the union-sponsored sales tax increase through mailers, yard signs, phone calls, going door-to-door, etc.
